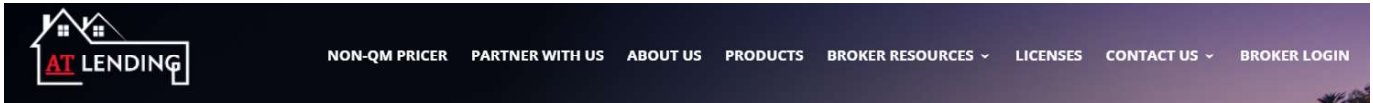


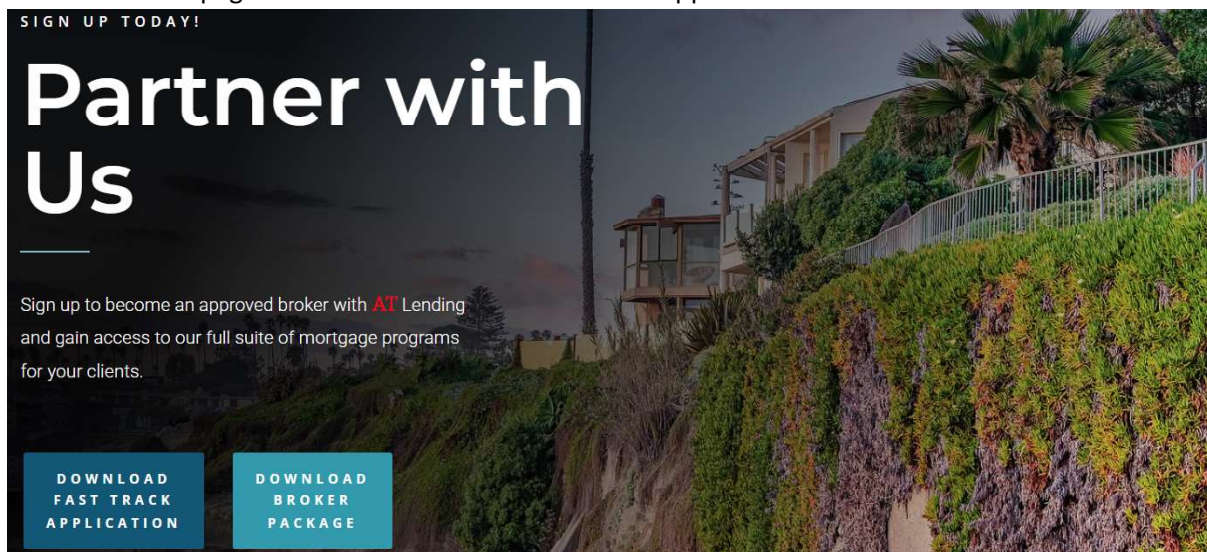


## Submitting Broker Applications
